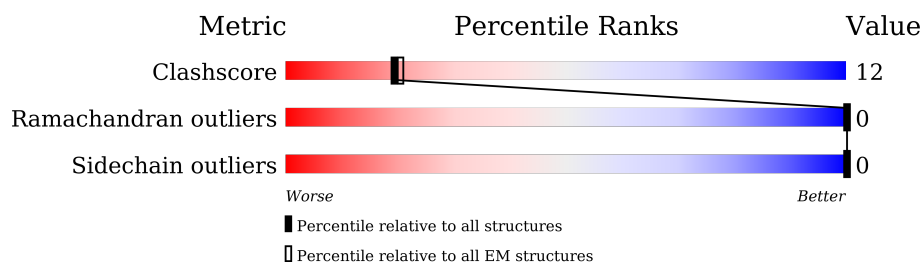
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.40 Å.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$.

There is only 1 type of molecule in this entry. The entry contains 17960 atoms, of which 0 are hydrogens and 0 are deuteriums.

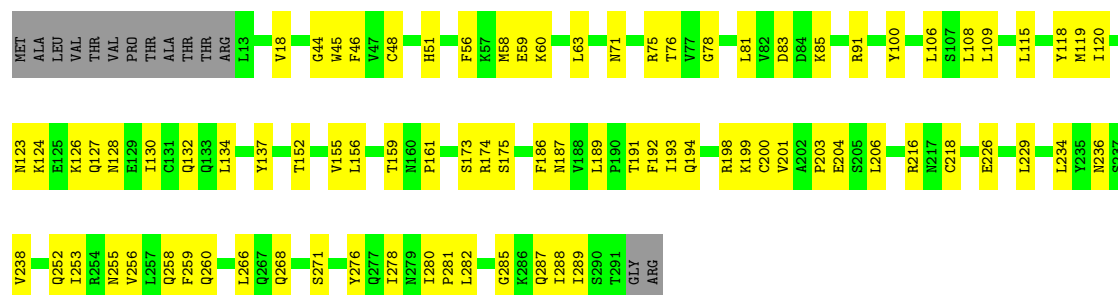

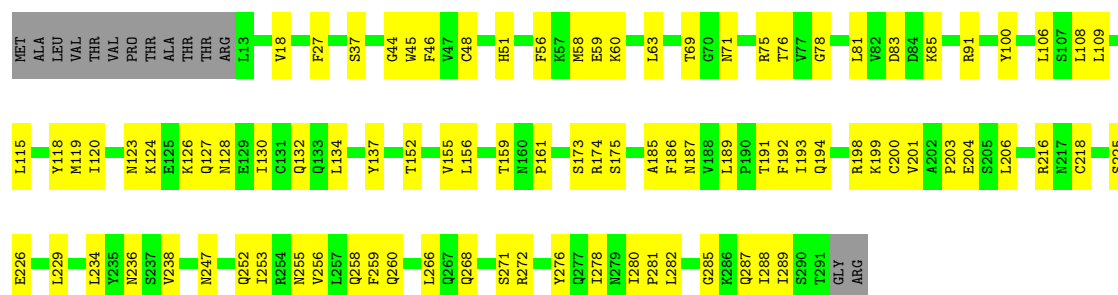

Chain E:  64% 31% 5%



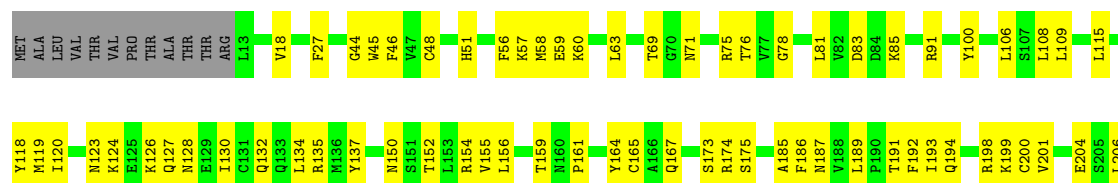

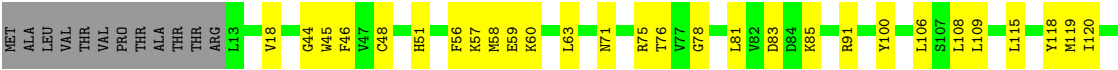
