

1 Overall quality at a glance (i)

2 Ensemble composition and analysis (i)




4 Residue-property plots (i)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.


• Molecule 1: Histone deacetylase complex subunit SAP30

7.1.3 Completeness of resonance assignments (i)


7.1.4 Statistically unusual chemical shifts (i)

7.1.5 Random Coil Index (RCI) plots (i)

The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. 













Violated and consistently violated restraints are shown using different hatch patterns in their respective categories





Violation analysis may find that some restraints are violated in very few models and some are violated in most of models. The following table provides this information as number of violated restraints for a given fraction of ensemble.



10.3.1 Bar graph: Dihedral-angle Violation statistics for the ensemble (i)






